- Cash Advance Either **\$15** or **3%** of the transfer, whichever is greater (maximum fee: **\$50**)
- Foreign Transaction **1%** of each transaction in U.S. dollars

#### PENALTY FEES

- Late Payment **Amount of minimum payment up to \$25.00**
- Over-the-Credit Limit **None**
- Returned Payment **Amount of the minimum payment up to \$20.00**

#### OTHER FEES

- Non-Automated Pay by Phone **\$10.00**
